
The **Fundación Comunidad Valenciana-Región Europea** is a non-profit foundation under the protection of the Valencian Regional Government.


How Pioneers into Practice attempt to reach its objectives?

- → Spend two one-month periods with leading European low-carbon innovation projects
- Participate in a series of two-day intensive workshops to share placement experiences and develop thinking on climate-change innovation
- Be mentored by leading European experts on transition management and get handson support from regional coaches
- → Get the opportunity to showcase your ideas at the annual Climate-KIC Innovation Festival and the wider Climate-KIC community

- → 2013 Call: 191 pioneers






...involving the Valencian society





FCVRE is the regional coordinator of the PiP programme in the Valencian region, but also the PiP coordinator at European level. As Regional Coordinator, FCVRE has created a structure called **PiP Management Team Comunitat Valencian** (PiP-MT-CV), which involves the main entities of the Valencian region to manage the programme and cover the main stakeholders in the region related to the Climate Change topic, taking into account the triple-helix, the challenge platforms and the region coverage.

Novel advances in organisations

Sustainable Management of the Scientce Park of Universitat de València

1. Analyse the SPUV energy consumption

Data Center UPS (Uninterruptible power supply)

2. New measures to improve the current energy management system reduce the operation cost of the facilities improve environmental image of the organization

Review and analysis of the historical electric bills.
Optimizating parameters in the electricity contract: Cost reduction: 9.000 €/year. Economic/financial

RESULTS

Cost Reduction of Facilities Implementation: Review of the UPS design to be adapted to the real consumption, with on-site measurements, achieving a cost reduction over 40%.

Reduction of Energy Consumption: Energy efficiency studies in the:

- Data Center
- UPS (Uninterruptible power supply). Reduction over 1.600 €/year




IG2: Transport and mobility

New business case / models / project proposals

- Submition of a EBRD tender "BURGAS integrated Urban Transport Project – Preparation of an enhanced Public Tariff System"
- An electrical motorbike charger that meters the energy consumption and provides extra information of multiple charge points
- A web tool that can advice the users to choose optimal routes in terms of travel time and climate-efficient: joining the number of vehicles circulating in a city with the measurement of CO2 levels in different city areas.
